## THE POOR PEOPLE'S CAMPAIGN

### A NATIONAL CALL FOR MORAL REVIVAL

In 2018, the Poor People's Campaign: A National Call for Moral Revival released its <u>Poor People's Moral Agenda & Declaration of Fundamental Rights</u>. Its demands address systemic racism, poverty, ecological devastation, militarism, and a distorted moral narrative that keeps these systemic injustices intact. The connections between these 5 themes are why we must continue to build power among the 140 million poor & dispossessed of this nation. Fight poverty, not the poor!

#### **IN North Carolina:**

#### **Poverty:**

- 44% of people in North Carolina are <u>poor or low-income</u>—a total of 4.6 million residents. This includes 53% of children (1.2 million), 46% of women (2.3 million), 58% of Black people (1.2 million), 67% of Latinx people (699 thousand), and 36% of White people (2.2 million).
- From 1979 to 2012, income for the top 1% grew by 129%, while income for the bottom 99% only grew 11%.

#### Systemic racism:

- 68% of the eligible voting-age population in North Carolina turned out to vote in 2016, out of 6.9 million eligible voters. That includes 69% of 1.5 million eligible Black voters, 53% of 350 thousand eligible Latinx voters, 59% of 211 thousand eligible Asian voters, and 68% of 4.9 million eligible White voters.
- More than 91 thousand residents cannot vote due to <u>felony disenfranchisement</u>, including over 42 thousand Black people (3% of the Black population in North Carolina).
- Of the over 36 thousand people <u>imprisoned</u> in North Carolina as of 2017, about 61% are people of color.
- Black residents of North Carolina are incarcerated at over 4 times the rate of White residents.

#### Militarism and the war economy:

- From 2008 to 2014, NC law enforcement received at least \$23.5 million in federal military equipment.
- North Carolina taxpayers contributed \$15.63 billion to the military in 2018.
- Over 181 thousand veterans have incomes <u>below \$35,000</u>—this is 25% of the NC veteran population as of 2015.
- North Carolina has 18 <u>ICE detention centers</u> as of 2019. Over 2 thousand people were <u>deported</u> from the state between 2003 and 2018, and over 37 thousand immigration removal cases are currently <u>pending</u>. Meanwhile, 325 thousand residents of the state are <u>undocumented</u>, and 9% of K-12 students have undocumented parents.

#### **Ecology and health:**

- 1 million people in North Carolina are uninsured as of 2018.
- 32% of census tracts in North Carolina are at-risk for being unable to afford water.

#### Family, community, and education:

- North Carolina currently ranks 22nd of all states in quality of <u>child education</u>. 61% of fourth graders are <u>not proficient in reading</u>, and 65% of eighth-graders are <u>not proficient in math</u> as of 2017.
- 1.6 million people benefit from the Supplemental Nutrition Assistance Program monthly as of 2016.
- As of 2015, 516 thousand children live in <u>food-insecure households</u>, 23% of all children in North Carolina.
- 29% of children in North Carolina have parents without secure jobs as of 2016 that's 664 thousand children.

#### **Everybody's got a right to live:**

- Over 9 thousand people in North Carolina are homeless as of 2018.
- Working at the 2018 state minimum wage, it takes 94 hours of work per week to afford a 2-bedroom apartment.
- 2 million make under \$15 an hour—50% of NC's workforce as of 2018, the 17th highest of all states.
- The minimum wage in North Carolina is \$7.25 in 2019. A living wage in the state in 2019 would be \$24.80 an hour.

# THE POOR PEOPLE'S CAMPAGN A NATIONAL CALL FOR MORAL REVIVAL

#### **NATIONWIDE:**

- Voting rights protections in many states are weaker than they were 50 years ago. 1 in 4 eligible voters isn't registered.
- The United States imprisons, detains and/or deports more people than any country in the world.
- 140 million people in the U.S. are poor or low-income over 43.5% of the population including 60.4% of Black people (26 million), 64.1% of Latinx people (38 million), 40.8% of Asian people (8 million), 58.9% of Native and Indigenous people (2.14 million), and 33.5% of White people (66 million).
- 53 cents of every federal discretionary dollar is spent on the military; only 15 cents goes to anti-poverty programs.
- At least 28% of children (20.7 million) in the U.S. have parents who don't have steady jobs. This includes 43% of Black children (4.4 million), 46% of Native/Indigenous children (265,880), 21% (781,935) of Asian children, 33% (6.2 million) of Latinx, and 22% (8.5 million) White children.
- 13.8 million U.S. households cannot afford water, and the poor are bearing the brunt of climate change effects.
- Native & Indigenous people are living with the ongoing legacy of genocide & systemic racism, with disproportionately high rates of poverty, homelessness, & overrepresentation in the US military, and continuous struggles to defend sovereignty & land rights. #### IT DOES NOT HAVE TO BE THIS WAY.

Contrary to common myths, our country — the richest in the world — has abundant resources to protect the environment and ensure dignified lives for all people.

- <u>This year</u>, the richest 1% of North Carolina residents are expected to receive 36% of the GOP tax law's benefits coming to the state. North Carolina's richest 1% can expect an average tax cut in 2020 of \$39,990, while the poorest 20% in the state can expect an average tax *increase* of \$20.
- North Carolina's contribution to <u>the country's endless wars</u> in Iraq, Afghanistan and beyond totals \$140.3 billion since 2001, and could instead have created over 97 thousand new jobs in clean energy, or placed every child in Head Start early childhood education programs, or covered Medicaid for over 2.1 million adults for the past 18 years.
- North Carolina has spent at least \$1.3 billion in <u>public subsidies for corporations</u> over the past five years that could have instead gone to our communities and our needs.

As revealed in the <u>Poor People's Moral Budget: Everybody Has the Right to Live!</u>, it is possible to invest society's resources to establish justice, domestic tranquility, security, & the general welfare for all.

- It would take \$750 million dollars over five years to implement automatic voter registration and make our democracy more secure. This is 1/1000 of the \$750 billion that are being committed to the Pentagon in 2018.
- If we cut \$350 billion in annual military spending, we would make our nation and the world more secure.
- We could raise \$886 billion in estimated annual revenue from fair taxes on the wealthy, corporations, & Wall Street to meet our urgent social & ecological needs.
- For every \$1 invested in early childhood education, society would gain \$7.30 due to reduced poverty, lower incarceration rates, & better health outcomes.
- Inaction on climate change could cost \$3.3 trillion per year for the U.S. economy the equivalent of five Great Recessions every year. A \$200 billion per year investment in clean energy transition would begin to address climate change and create 2.7 million new jobs.
